ACKNOWLEDGMENT AND ASSUMPTION OF RISKS, RELEASE AND INFORMED CONSENT

In consideration of my participation in the Driving Lessons (as defined below) and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. I hereby consent to my participation in the driving lessons, including without limitation the in-car driving lessons, being held by the Instructor for the Driving School (collectively, the "Driving Lessons"). I have been provided the opportunity to ask questions, seek clarification and consider my participation in the Driving Lessons. I understand that my participation in the Driving Lessons is voluntary.
2. I represent to the Instructor and the Driving School that I am in good physical condition and have no known conditions, impairments or maladies that would in any way endanger myself or other participants during the Driving Lessons. I understand that the Driving Lessons may involve driving a vehicle and that driving a vehicle by its nature has inherent risks and dangers that can result in serious bodily injury or death. These risks and dangers further include risks of contracting any and all communicable diseases, germs, bacteria, viruses or infections, including without limitation the virus responsible for COVID-19, whether now known or later discovered (hereinafter referred to collectively as "communicable disease"). I further understand that the Instructor and Driving School adhere to the guidance and directives mandated by the Ontario Government and local health authorities when conducting the in-car training amidst the COVID-19 pandemic (O. Regulation 263/20). I acknowledge and confirm that I accept these risks as a condition of participating in the Driving Lessons.
3. I hereby expressly and specifically assume the risk of injury or harm in connection with the Driving Lessons and release and forever discharge the Instructor, the Driving School, and each of their respective affiliates, shareholders, subsidiaries, members, directors, officers, employees, agents, insurers, suppliers, retailers and representatives (collectively, the "Released Parties") from any and all liability for injury, illness, communicable disease, death, or property

damage resulting from my participation in the Driving Lessons, regardless of whether such injury, illness, communicable disease, death, or property damage is caused, in whole or in part, by the fault or negligence of the Released Parties. I agree to hold harmless, defend and indemnify the Released Parties for and from any and all claims, demands, causes of action, lawsuits, damages, injuries, expenses (including attorneys' fees) and other liabilities of any kind arising from or in connection with my participation in the Driving Lessons.

4. This Acknowledgement and Assumption of Risks, Release and Informed Consent (this "Release") shall be governed by and interpreted exclusively under the laws and jurisdiction of the Province of Ontario. I consent to the exclusive jurisdiction of the provincial and federal courts of Ontario for resolution of all claims, differences and disputes (if any) which arise under this Release.

5. I hereby warrant that I have read this Release prior to its execution and am fully familiar with and understand the contents hereof. This Release shall be binding upon me and my heirs, legal representatives, and assigns.
